# Minutes of the DYMAT Association General Assembly held at the Palazzo dei Congressi, Lugano, Switzerland, September 10<sup>th</sup>, 2015

#### 1. President's report

Hervé Couque opened the General Assembly on behalf of Stefan Hiermaier, who could not be present.

The main public activities during Stefan Hiermaier's presidency: 30<sup>th</sup> anniversary meeting in Paris in 2013; the 21<sup>st</sup> Technical Meeting in London in 2013 on dynamic imaging; the Hopkinson centenary meeting in Cambridge in 2014. Publications: 21<sup>st</sup> Technical Meeting proceedings; Hopkinson Centenary proceedings (as well as two themed issues of *Philosophical Transactions A*); EPJ-ST and EPJ Web of Conferences as records of the 11<sup>th</sup> International Conference.

There is a need to integrate the conflicting interests of publishers and authors when considering future publication of International Conferences. We will need to adjust to the extra time required to review and revise papers for journal publication.

Student camps or summer school for PhD students? Credits needed for students from some countries.

Question: can a sponsor be found for the proposed summer school?

#### 2. Vote to accept the President's report

The President's report was accepted by the Assembly with no objections.

## 3. Treasurer's report

Eric Buzaud said the accounts up to 26<sup>th</sup> July 2015 were reviewed by himself and Antonio Cosculuella along with two DYMAT members not on the Governing Board (Christophe PONTIROLI and Benjamin ERZAR). See Appendix 1.

# 5. 22<sup>nd</sup> Technical Meeting

Pascal Forquin told us the theme will be 'Experimental testing and modelling of brittle materials at high strain rates'. The place is Grenoble, France. The dates are October 12-14, 2016. He hopes for 60-100 participants.

#### 6. 12<sup>th</sup> International Conference (2018)

This will be in Arcachon, near Bordeaux. Antonio Cosculluela made a presentation. September 10-14, 2018.

#### 7. Election of the Board

There were 8 vacant places on the Board. There were 9 candidates for these vacant places: Eric BUZAUD, Ezio CADONI, Sandra GUERARD (new candidate), Stefan HIERMAIER, Mikko HOKKA (new candidate), Leopold KRUSZKA, Eric MARKIEWICZ, Nuno PEIXINHO, Stephen WALLEY The Assembly then voted on these candidates. Daniele FORNI and Andreas HEINE acted as tellers. 54 valid ballot papers (including proxies) were received. There were no invalid ballot papers.

The candidates received the following number of votes: Eric BUZAUD (49), Ezio CADONI (53), Sandra GUERARD (52), Stefan HIERMAIER (54), Mikko HOKKA (37), Leopold KRUSZKA (43), Eric MARKIEWICZ (49), Nuno PEIXINHO (41), Stephen WALLEY (54) BUZAUD, CADONI, GUERARD, HIERMAIER, KRUSZKA, MARKIEWICZ, PEIXINHO & WALLEY were therefore declared elected to the board to serve for 2 years.
